



PRODUCT DESCRIPTION

GraniteShares 3x Short Facebook Daily ETP is a collateralised Exchange-Traded Product (ETP). The ETP tracks, excluding fees and other adjustments, the performance of the Solactive Daily Leveraged 3x Short Facebook Inc Index that seeks to provide -3 times the daily performance of Facebook shares. For example, if Facebook rises by 1% over a day, then the ETP will fall by 3%, excluding fees and other adjustments. However, if Facebook falls by 1% in a single trading day, then the ETP will rise by 3%, excluding fees and other adjustments.

- Magnify returns in a single trade
