

# What is the product?

Objectives	GraniteShares 1x Short FATANG Daily ETP is designed to enable investors to gain -1 time exposure to a total ref investment in FATANG Equal Weight Index TR (the "Underlying Stock" ).				
	For example, if the Underlying Stock was to rise in value by 5% on a particular day, the product is designed to decrease in value by 5% on that day (minus fees and adjustments) and if the Underlying Stock was to fall in value by 5% on a particular day, the product is designed to increase 5% in value by on that day (minus fees and adjustments).				
	For periods longer than one day, the return of the product is not the same as the return of the Underlying Stock multiplied by, -1 (the "Leverage Factor"). This is because the Leverage Factor is reset on a daily basis (i.e. the Leverage Factor is applied to the performance of the Underlying Stock on each day). The daily reset has a "compounding effect" which means that, the more volatile the performance of the Underlying Stock, the more the performance of the product will deviate from the performance of the Underlying Stock (multiplied by the Leverage Factor) over a given period of time. ### Term of the PRIIP

This product does not have a fixed term. The term will depend on how long you choose to hold the product however, the scheduled maturity date is 01 July 2070. GraniteShares Financial plc is entitled to terminate this product unilaterally.



The risk indicator assumes you hold the product for 1 day. The actual risk can vary significantly if you hold the product for a longer timeframe and you may get back less. You may not be able to sell your product easily, or may have to sell at a price that significantly impacts on how much you get back.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the market or because we are not able to pay you.

We have classified this product as 6 out of 7, which is the highest risk class.

This rates the potential losses from future performance at a very high level, and poor market conditions are very likely to impact the performance. This product does not include any protection from future market performance, so you could lose some or all of your investment. If we are not able to pay you what is owed, you could lose your entire investment.

# Factors affecting the return of the product at the end of the recommended holding period

What could affect my turn positively? A decrease in FATANG Equal Weight Index TR

What could affect my return negatively? An increase in FATANG Equal Weight Index TR

# What happens if GraniteShares Financial plc is unable to pay out?

The product is not protected by the Irish Deposit Guarantee Scheme or any other investor compensation or guarantee scheme. # Recommended holding period: One (1) day

Holding this product for more than one day is likely to result in a return which is different than -1 times the return of the Underlying Stock over that holding period. The compounding effect may have a positive or negative impact on the product's return, but tends to have a negative impact the higher the volatility of the Underlying Stock.
