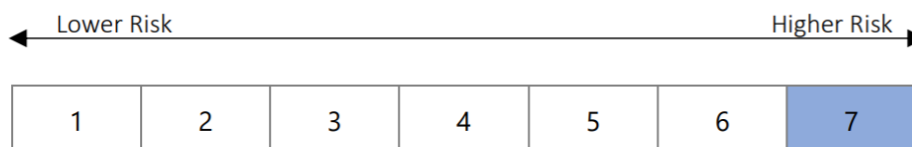
What is the product?

Type	Collateralised Exchange Traded Product (“ETP”) Securities
Objectives	GraniteShares 3x Long Vodafone Daily ETP is designed to enable investors to gain Solactive Daily Leveraged 3x Long Vodafone Group PLC Index time exposure to a total return investment in 3 (the “Underlying Stock”) Vodafone Group Plc undefined. For example, if the Underlying Stock was to rise in value by 5% on a particular day, the product is designed to increase in value by 15% on that day (minus fees and adjustments) and if the Underlying Stock was to fall in value by For periods longer than one day, the return of the product is not the same as the return of the Underlying Stock multiplied by, (the “Leverage Factor”). This is because the Leverage Factor is reset on a daily basis (i.e. the Leverage Factor is applied to the performance of the Underlying Stock on each day). The daily reset has a “compounding effect” which means that, the more volatile the performance of the Underlying Stock, the more the performance of the product will deviate from the performance of the Underlying Stock (multiplied by the Leverage Factor) over a given period of time. This deviation can be positive or negative. The product is an exchange traded product (ETP). You may trade this product on various stock exchanges at your own discretion. You may lose the full value of your initial investment, but you will not lose more than your initial investment. The product is backed by a swap with Natixis (the “Swap Provider”). The payment obligations of the Swap Provider to GraniteShares Financial plc are protected by collateral held in a segregated account at an independent custodian , The Bank of New York Mellon SA/NV.

Term of the PRIIP

This product does not have a fixed term. The term will depend on how long you choose to hold the product however, the scheduled maturity date is 01 July 2070 . GraniteShares Financial plc is entitled to terminate this product unilaterally.

What are the risks and what could I get in return?



The risk indicator assumes you hold the product for 1 day. The actual risk can vary significantly if you hold the product for a longer timeframe and you may get back less. You may not be able to sell your product easily, or may have to sell at a price that significantly impacts on how much you get back.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will

lose money because of movements in the market or because we are not able to pay you.

We have classified this product as 7 out of 7, which is the highest risk class.

This rates the potential losses from future performance at a very high level, and poor market conditions are very likely to impact the performance. This product does not include any protection from future market performance, so you could lose some or all of your investment. If we are not able to pay you what is owed, you could lose your entire investment.

Be aware of currency risk. If you receive payments in a currency different to that of your home jurisdiction, the final return you will get will depend on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

Performance Scenarios

The scenarios shown illustrate how your investment could perform. You can compare them with the scenarios of other products. What happens if GraniteShares Financial plc is unable to pay out?

The product is not protected by the Irish Deposit Guarantee Scheme or any other investor compensation or guarantee scheme. This means that if GraniteShares Financial plc is unable to pay out, you may lose all of your investment. Since the ability of GraniteShares Financial plc to pay out depends on receiving amounts due under the product from the Swap Provider, the Swap Provider provides assets daily to a segregated account as collateral for such obligations with a value equal to or in excess of the value of the daily price of the product. If the Swap Provider is unable to pay GraniteShares Financial plc, its ability to pay out will be limited to the amounts realised from such collateral, as further explained in the Prospectus.

What are the costs?

Costs over time

The Reduction in Yield (RIY) illustrates the impact the total costs you pay may have on your investment return. The total costs take into account one-off, ongoing and incidental costs.

The amounts shown here are the cumulative costs of the product itself, for the recommended holding period, and assume you invest £10000. The figures are estimates and may change in the future.

How long should I hold the product and can I take my money out early?

Recommended holding period: One (1) day

Holding this product for more than one day is likely to result in a return which is different than 3times the return of the Underlying Stock over that holding period. The compounding effect may have a positive or negative impact on the product's return, but tends to have a negative impact the higher the volatility of the Underlying Stock.
