


## **PRODUCT DESCRIPTION**

GraniteShares 1x Short GAFAM Daily ETP is a collateralized, Exchange-Traded Product (ETP). The ETP tracks, excluding fees and other adjustments, the performance of the Solactive Daily Leveraged 1x short GAFAM Index that seeks to provide -1 times the daily performance of Solactive GAFAM Equal Weight Index TR.

The Solactive GAFAM Equal Weight Index TR provides exposure to Amazon, Apple, Alphabet, Meta Platforms Inc, Microsoft with each component equally weighted after each quarterly rebalancing.
