
What is the product?

Objectives	GraniteShares 3x Long STMicroelectronics Daily ETP Securities is designed to enable investors to gain 3 time exposu total return investment in STMicroelectronics (the "Underlying Stock").				
	For example, if the Underlying Stock was to rise in value by 5% on a particular day, the product is designed to increase in value by 15% on that day (minus fees and adjustments) and if the Underlying Stock was to fall in value by 5% on a particular day, the product is designed to decrease 15% in value by on that day (minus fees and adjustments).

Term of the PRIIP

Recommended holding period: One (1) day
