

## GraniteShares YieldBOOST QQQ ETF

### PRODUCT OVERVIEW

The GraniteShares YieldBOOST QQQ ETF (“TQQY”) is designed to maximize yield from options strategies linked to Nasdaq-100® Index (QQQ®). To generate yield, TQQY sells put options on leveraged ETFs linked to QQQ. To try to mitigate extreme down movements in the Nasdaq-100®, TQQY buys put options on leveraged ETFs. TQQY aims to make monthly distributions.
